Soon, the holidays will be upon us, the world will seem to spin faster and the "extra" hour that we got back will not be near enough time to get all that we need done. But, as board of education trustees you will do some very important work before the year winds down and the new one begins. There are budget parameters to begin developing numbers around, policies and regulations to adopt for new federal and state requirements and lots of school functions to attend. You will also need to anticipate what other bills might be signed by Governor Cuomo before year's end and what his Executive budget proposal might have in it for education in the way of funding and policy when it is introduced in January. And currently, both the Senate and Assembly education chairs are doing round tables across the state to hear about the issues related to the Foundation Aid formula.

The 2020 legislative session overall will be shortened to June 2, but extra days have been built in during the other months to make up for some of this. However, that will mean more time during the week in Albany for legislators and more immediacy around their decisions. The timeframe between when the budget should be adopted on April 1 and June 2, has only 19 session days in it. We will need to work diligently to keep up.

I urge all of you to keep calm and press forward. Together your voices are extraordinarily powerful. Our legislators know that you carry the information needed for them to make the best decisions on behalf of public education and, just as importantly, the will of your constituents. Let us know how we can help and, as always, we are thankful for each and every one of you and all of the work that you do.

### Added MCSBA legislative priorities identified

Members of the 2019-2020 MCSBA Legislative Committee in September set priorities including foundation aid, funding for mandates, teacher/staff shortages, ESSA reporting, and funding for preK programs. At their October meeting, members added funding sources for safety and security, including mental health needs for students, as an additional priority. They also discussed pursuing funding options outside the normal academic funding streams provided to schools.

Members also set up sub-committees to prepare separate position papers on teacher and bus driver shortages. The goal is to have the positions approved by the Executive Committee during its December meeting for use early in 2020.



# Meeting with NYS Senator Funke

On October 22, MCSBA met with NYS Senator Rich Funke to discuss concerns about new unfunded mandates, as well as the difficulty in finding teachers and bus drivers. They thanked the senator for supporting a higher BOCES superintendent cap, staggered school building surveys, permission for a TRS reserve, the disconnect of APPR from testing, and provisions to pay for safety and security measures outside of the 2% tax levy cap.

### School District & Mental Health Partnerships in Monroe County



During its October meeting, the Information Exchange Committee explored how member districts collaborate with the county and health care providers to meet the mental health needs of students. Presenters were **Chuck Allan**, Children's Project Coordinator/ Education Liaison, Monroe County Department of Human Services; **Lynn Carragher**, Assistant Superintendent for Inclusive Education and Instruction (Bro); and **Bill Patterson**, Rochester Regional Health.

Among their comments were the following:

\* The study of trauma and its impact on children has led to recognition of the importance of mental health services for children and families.

\* Several collaborations exist involving schools districts with hospitals, mental health clinics, community schools, and other sources of mental health support for students. Each collaboration helps to promote better understanding of how each partner works.

\* The Rochester Regional Health (RRH) Community School Program includes outpatient clinics operating in schools as satellite offices to achieve better therapy attendance and a reduction of barriers to service and loss of instructional time. Districts pay a fee for outpatient clinical services in addition to costs paid by the patients insurance to make the program viable under NYS regulations. The on-site clinics help to build trust between families and school staff.

\* Since the on-site clinic system is insurance based, high deductibles and copays limit accessibility for some families.
