Dear Members,

About the same time, I announced I would retire at the end of this school year and in between, Beckie Schultz also made the decision to retire as program director.

On top of their family obligations, their regular jobs, and their commitments to their Boards, your officers had a lot on their plates this year that they surely didn't plan for. Their leadership this year has been nothing short of remarkable!

It is clear to us now that the COVID-19 pandemic isn't done with us yet and that the economic impacts will remain along with the personal ones. I want to commend all of you for the work that you have done together this past year on behalf of the students you serve. Whether by Zoom or in person, you continued your professional development and participated in advocacy for the resources that your districts need. You took the time to network and share your experiences, your frustrations, and your successes with one another. Once again, you led by example.

This association is poised to continue its work to support all of you as you strive to provide excellence in education for all students. While a simple mission statement, the work is not. But I am confident that under your new Executive Director, Amy Thomas, with Nancy Pickering as program director and Mary Talbot's enduring dedication to this association, you will continue to do extraordinary things.

It has been the honor of my life to serve all of you in this role and know that while I might leave you to begin my next life's journey, my admiration and respect for all of you remains.

### 2021-2022 MCSBA Highlights

### Advocating, Educating, Representing

The school year began as the last one ended, with the pandemic still impacting students, staff and families. After a summer of planning for a post-COVID learning environment, districts returned to full-time, in-person learning with a mask mandate in place. BOE meetings became contentious as residents attended meetings to use the Public Comments portion of the agenda to share their views on masking, vaccination, and Critical Race Theory.

Districts were careful to educate their communities that Federal funds could not be used for tax relief and would create a financial cliff for districts when the funds are gone, if they are used for ongoing staffing and programs. Districts were thoughtful in their use of funds to support student learning and supports to bridge the gap created by the pandemic.

In November, the MCSBA office staff moved to a new location at 333 Metro Park, Suite C-102 in Brighton. The office space is spacious and user-friendly, with room to grow.

In December, MCSBA hosted two Zoom meetings with 14 of our local representatives as the pandemic continued to make travel to Albany impossible. We discussed the continued impact of the tax cap, support of expense-based aids and raising the aidable salary for BOCES to increase access and opportunity for our students, and the recruitment and retention of a diverse bus driver pool.

The Association was able to return to an in-person Legislative Breakfast. On February 5, 2022, 16 legislators and over 90 MCSBA members attended the event held at the DoubleTree Hotel. Twenty MCSBA members served as Table Leaders and the talking points included a great deal of discussion around ending universal masking in schools. Other topics included the critical shortage of bus drivers and extending the timeline for the transition to zero emission buses. The Association asked for legislative support to increase the aidable salary for CTE instructors from \$30,000 to \$60,000 with a comparable increase in special services aid over the next three years. We continued to advocate for a change in the tax cap limit to 2% or the CPI whichever is higher, the elimination of negative tax caps, provide specific exclusions for costs like special education, mental health and social emotional learning, and to remove the 60% supermajority override requirement.

Executive Director Sherry Johnson facilitated a Zoom meeting with U.S. Representative Joe Morelle to discuss the impact of TikTok in encouraging disruption of the school environment. Bo Wright (MCCOSS), MCSBA Officers, and both District Superintendents participated in the meeting.

In March, NYS Senator Samra Brouk hosted a media conference at Monroe One BOCES to promote the importance of CTE (Career and Technical Education) and extending CTE state funding. MCSBA Executive Director Sherry Johnson stated that Association members were grateful to Senator Brouk for prioritizing increases to the BOCES aid formula for the CTE program in this year's state budget.

Led by Co-Chairs Kim McCluski (B2) and Kathy Dillon (B1, CC), in anticipation of the May Budget Vote and Board of Education elections, the Communications Outreach Advisory Committee (COAC) met to develop talking points for school boards around *The Role of the Board of Education and Board Service*. BOE members were given talking points on the following questions: 1) Reasons to serve on a school board; 2) What is the most important role of school board members and how do members work together to achieve this? 3) How does a district's board of education impact the culture and climate of a district? and 4) If we regard our public schools as one of the most important assets in a community, what is the responsibility of the board to maintain that asset? Other information was provided for *What is the most rewarding part of serving on a board?* and *Do Boards of Education follow a code of ethics?* 

### 2021-2022 Community Connections

### **ACT** for Education



A Community Together (ACT) for Education is an initiative by the Monroe County Council of School Superintendents for the Monroe One and Monroe 2-Orleans BOCES component districts and the RCSD. Working with area businesses, community members and other partners, the ACT Steering Committee works to deliver positive messaging about our local school districts and encourage community support of public education.

ACT has continued to work with Causewave Community Partners to expand informational programing with a series of roundtable webcasts on issues related to public education. The webcasts were moderated by Jo Anne Antonacci, District Superintendent, Monroe 2-Orleans BOCES and Daniel White, District Superintendent, Monroe One BOCES and included local superintendents and other officials related to public education. The webcasts have been well received by viewers and include topics such as:

A User-Friendly Guide to the Many Moving Parts of a School District's Budget
Earning the "Seal of Civic Readiness"
Social Emotional Wellness and Resources
COVID Vaccinations and Testing

Programing during both *Celebrating Public Schools Week* and the *2021 National Small Business Week* further showcased partnerships with local business that benefit Monroe County students. ACT for Education has representation on the Rochester Chamber of Commerce's Education Committee.

The JA Titan of Business Challenge is a regional business strategy tournament for students utilizing Junior Achievement's Titan Simulation Model. After the competition, students, sponsors and community business leaders joined together for the JA Titan Luncheon, Awards Ceremony and a Keynote Address by a local "Titan" of business. At the luncheon, ACT for Education showcased the finalists of the *Community Champion for Education Award* and announced the yearly winner.

### **Supporting Our Schools Through Board of Education Service**

Each district's Board of Education plays a very significant role in the community. Through video vignettes created by BOCES 2 and posted on the ACT for Education website, current board members shared their thoughts on the role of a board, its impact on culture and climate, important responsibilities, and the rewarding experiences of serving on a Board of Education.

The MCSBA.org website provides easy access to information and programing offered by the Association for member districts and the general public.


Each Friday, MCSBA emails a Weekly Education Update (formerly known as E-Clips) on educational issues to members and others interested in staying abreast of current educational topics.



### **2021-2022 Advocacy**

### Legislative Breakfast – February 5, 2022

On February 5<sup>th</sup>, over 120 MCSBA members and officials from local, state, and the federal government met to discuss issues important to public education. Led by Legislative Committee Co-Chairs Vincent Antonicelli (ER) and Matthew Metras (WI), school board members and administrators met with federal, state, and local elected and appointed officials whose decisions affect schools. In opening comments, Executive Director Sherry Johnson identified Association priorities, praised members for coping with issues caused by the pandemic, and thanked them for providing their voices on behalf of those who have yet to find theirs.

MCSBA members then met with invited officials in two sessions so each participant was able to converse with at least two representatives. Discussion topics included:

- · Continue full funding commitments to Foundation Aid and Expense based aids.
- Provide meaningful flexibility to the tax cap by allowing exceptions for costs that exceed 2% and provide for a simple majority override of the tax cap.
- Continue to support our efforts to deal with the shortages of bus drivers and work with us to recruit and retain faculty and staff.
- Provide direct support for mental health access and services.
- Increase the BOCES aid formula for Career and Technical Education programs (CTE) and special services aid.
- Provide school districts the metrics needed to move into a post-pandemic learning environment.

Elected officials were also invited to make comments to the whole group. During his comments, Congressman Joe Morelle presented Executive Director Sherry Johnson with a plaque commemorating her work in the community.

### **2021-2022 Advocating**

### Legislative Committee

The Legislative Committee prepares and promotes the Association's legislative positions. This year, under the leadership of Matt Metras (West Irondequoit) and Vincent Antonicelli (East Rochester) the committee met with local representatives via Zoom in December and hosted an inperson Legislative Breakfast in February.

Members identified the following priorities 1) Funding/Federal stimulus money while helpful, is only one-time funding; 2) Testing requirements for unvaccinated staff and students; 3) Quarantined students; 4) Bus driver shortages/CDL requirements; and 5) Overall staff shortages.

The Association monitored Senator Gillibrand's bill called *The Universal School Meals Act*, which would provide breakfast, lunch dinner and a snack to all school aged children regardless of income. Fourteen legislative committee members had a productive meeting with Assemblyman Bronson regarding the current bus driver shortage and possible long-term solutions.

### COAC: Communications Outreach Advisory Committee



Culturally Responsive-Sustaining Framework (CR-S Framework) is a set of guidelines NYSED developed in 2018 to guide the implementation for culturally responsive education. Talking points on the Framework were distributed to Association members and included four principles: A Welcoming and Affirming Environment; High Expectations and Rigorous Instruction; Inclusive Curriculum and Assessment; and Ongoing Professional Development.

In the fall of 2021, COAC refined the MCSBA position paper on *Public Education – The Federal Role: Support, Not Governance* for use with our representatives at the February Legislative Breakfast.

### 2021-2022 Member Networking Opportunities

The Board Leadership committee, made up of Board of Education presidents and vice presidents, was again one of the Association's most important offerings. The meetings for members to network with their peers to share ideas and concerns with each other regarding their leadership roles and responsibilities was especially important this year due to the tumultuous atmosphere around BOE meetings. Members met throughout the year to support each other and problem solve through the ever-changing issues related to student and staff safety in the pandemic, the discourse at school board meetings and national issues impacting our local school districts.

Similarly, the district clerk's seminars that are offered by the Association annually in spring and fall helped district clerks support each other and navigate through a number of pandemic related issues over the past three years. These seminars included topics self-selected by the district clerks and also served as critical networking and mentoring opportunities.

### Role of Race & Ethnicity in K-12 Education

On July 26, 2021 more than 90 MCSBA members attended a professional development opportunity hosted by MCSBA, Monroe One BOCES, and Monroe 2-Orleans BOCES entitled *The Role of Race & Ethnicity in K-12 Education*. The session included a presentation by Dr. Sean Eversley Bradwell, Assistant Professor, Department of Education in the School of Humanities and Sciences at Ithaca College. There were small group discussions among members to further explore the topic.
