# From Executive Director Amy J. Thomas



Dear Members,

Our Association's achievements are deeply rooted in the collaboration and dedication of our members. Throughout this past year, we've strived to adapt our professional development initiatives to meet the evolving educational landscape in the wake of the pandemic. Covering a diverse array of crucial topics such as AI's impact on education, cybersecurity, zero-emission buses, book challenges, effective board meeting management, public comments policy, civil service law, superintendent searches, and RASHP updates, our programs have aimed to remain at the forefront of educational discourse.

Additionally, we've had the pleasure of hosting two special events for our entire membership. The first centered around the solar eclipse at RMSC, offering invaluable insights to this historical event that directly impacted the Rochester area, while the second was a tour of the Golisano Institute, showcasing their innovative post-secondary entrepreneurial degree program. These events, alongside our regular programming,

thrive on the expertise generously shared by educational leaders within our greater Rochester community and within our member districts.

Our advocacy efforts have also been robust, as demonstrated by our engagement with government leaders to champion our legislative priorities. From our annual trip to Albany, via the adventurous Amtrak journey, to our meetings with legislators, representatives, SED, the Governor's office, and the Board of Regents, we've remained steadfast in advocating for the interests of our membership school districts. Our legislative breakfast was a definite highlight this year. The inclusion of student voice to reinforce why our collective advocacy matters and who it ultimately impacts, was well received by our legislative representatives and our membership. My thanks to the student representatives from Greece, Pittsford, the Rochester City School District, West Irondequoit, and Wheatland-Chili!

As I write this message, Governor Hochul's \$237 billion budget has been announced, and thankfully it averted cuts to save-harmless and incorporated a higher inflation adjustment than the Governor initially proposed. We will gladly accept the small victories while continuing to advocate for what our school districts – our students – deserve! As we enter the new school year, we will be paying close attention to the \$2 million appropriated to the Rockefeller Institute to conduct a study on the foundation aid formula.

Reflecting on the changes within MCSBA over the past year, our most noticeable transformation is our new logo, thanks to the efforts of Monroe-2 Orleans BOCES Communication & Technology Services (CaTS). This logo symbolizes our commitment to providing professional development to our member districts. Our programming has reached record levels of in-person attendance (with enhancements to those participating virtually), we elevated the legislative breakfast by incorporating student voice, and hosted two social hours for the membership again this year. And, last but not least, we've also welcomed Tammy Gurowski as our new Office Manager.

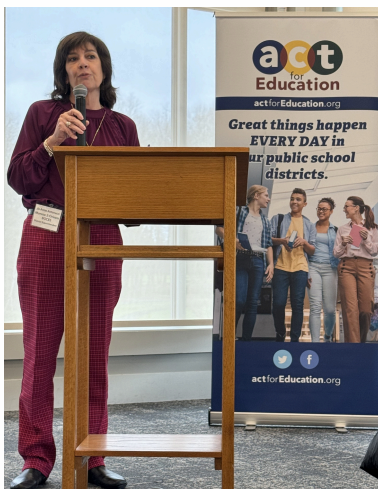
