From Our Executive Director

A Year of Transitions



Dear Members,

“The more things change, the more things stay the same” so the saying goes. This year there was a lot of change at MCSBA.

First, there were major changes in our office. With Jody Siegle leaving for retirement, the Executive Director’s position needed to be filled. I was honored and humbled to be given the nod by the hiring committee and subsequently, the Executive committee to lead MCSBA in this new capacity. Since I served the organization as the Assistant to the Executive Director, one of my first responsibilities was to fill my vacated position. Beckie Schultz now expertly fills that place for us with dedication and passion. Both Beckie and I are grateful to the compassionate and knowledgeable guidance of Mary Talbot in her role as Office Manager in keeping us all a functioning unit.

In December, President Obama signed into law, the Every Student Succeeds Act, reauthorizing the much needed changes to the Elementary and Secondary Education Act. This bi-partisan legislation returns to states and local boards of education the authority to make decisions related to the education of students. While the rules and regulations for ESSA are still being debated, it is clear that Congress wants the federal role in education to hold a much smaller footprint; a welcome shift. It was something that the Association membership advocated for throughout the fall and those efforts, along with others outside of our organization, paid off.

In January, Meryll Tisch announced that she would not seek re-election to the NYS Board of Regents and following that announcement, two other Regents also chose not to continue in their roles. We now have a new Chancellor in Dr. Betty Rosa and a new Vice-Chancellor, our own T. Andrew Brown. This Board of Regents has also reframed the conversation about how students receive their instruction and are assessed. SED Commissioner, MaryEllen Elia who has been hard at work for less than a year has her own ideas as well. The Commissioner drew a lot of attention at our fall law conference and we are looking forward to hearing from her again at this fall’s conference.

Also, in January, the much dreaded tax cap number came out and while it wasn’t zero as expected, it might as well have been at 0.12%. For our districts this was going to mean difficult decisions for closing budget gaps created by the GEA and frozen Foundation Aid. Again, through a great deal of advocacy, the legislature returned, in one year, not two, the rest of the GEA dollars owed to our districts.

While these were all significant changes, our vision, our mission and our goals remain steadfast. Supporting all of you, while you navigate through these changes is what we do. We may work with new leaders and new legislation, but we remain strong because all of you believe in and support public education as the best path for the next generation. Thank you for all that you do.

2015-2016 Highlights at MCSBA

Advocating, Educating, Representing

Funding for Public Education – Remains Association Goal #1

Funding for public schools once again became the guiding conversation of the association in all of its advocacy opportunities for the year. Meetings with legislators in the fall both locally and in Albany targeted elimination of GEA, unfreezing of foundation aid, and completing regulations for BOCES construction and PILOTS that would mitigate some of the impact of the tax cap. At the legislative breakfast in February, these issues were revisited as the true impact of a 0.12% tax cap on local districts was known. Requests to untie the cap from the CPI and removal of the supermajority requirement for budgets over the cap were added. The two-day spring trip to Albany once again highlighted these same funding issues and addressed other diversions of public school funds such as the Governor's Parental Choice Act and additional funding for Charter schools. Educating lawmakers on the impact a \$15/hr minimum wage would have on school districts prior to its inclusion in the state budget was also a key focus of the trip. MCSBA districts were well represented in all advocacy efforts.

The Communication Outreach Advisory Committee met to develop talking points on ENL/ELL CR-154 Regulation changes and Assessments and advocated for the reauthorization of ESEA.

After discussion at the initial COAC meeting in September, a letter and resolution were drafted advocating for the reauthorization of the Elementary and Secondary Education Act. Districts were able to use these materials at their discretion and many sent them on to their Senators.

The committee also met several times to develop talking points for members related to emerging issues. Specific talking points were developed on ENL/ ELL regulation changes entitled **"All teachers are teachers of English Language Learners...A Foundation for School Leaders"** in October and **"The ABC's Of Assessments"** in February. Community Connections

MCSBA collaborates with a number of groups to promote public education.

MCSBA continues its representation on the **Council of Governments (COG)** where members collaborate with other officials on common issues.

The **Monroe County Superintendents Public Education Advocacy Committee (MCSPEAC)** continues to develop information about our public schools to help the greater community understand the value and strengths of public education in our county. This year the committee worked with Causewave Community Partners, formally the Ad Council of Rochester to show the generous and varied ways school children give back to their communities and to increase business sponsored television commercials that highlight the success of our public school districts.

The **Monroe County Education Coalition (MCEC)** includes the PTA, school boards, superintendents, teacher unions, administrators, and school business officials. MCSBA provides and maintains a MCEC website at www.mcsba.org.

MCEC Coalition Members published an editorial on the unintended consequences of the NYS Tax Cap and met with local Legislators.

MCEC members developed an editorial on the unintended consequences of the NYS Tax Cap that was published in the Democrat and Chronicle in November and met with local legislators in February. Topics for the meeting included funding (restoration of GEA, full phase in of Foundation Aid and opposition to STAR changes) as well as opposition to the proposed Parental Choice Act and continued help with state testing and APPR issues. Members also presented data illustrating that local Charter Schools have not created the student achievement gains expected at their inception. MCEC is currently celebrating its 20th year of service to the children of Monroe County.





2015-2016 Conferences

Each year, MCSBA presents a number of conferences that attract school board members and administrators from within and beyond Monroe County. In 2015-2016, MCSBA held three district clerks seminars, a law conference, and two SED approved seminars, Finance and Governance for new school board members. The Law conference provided an opportunity for local board members to meet the newly appointed Commissioner of Education, MaryEllen Elia, and gain perspective on how she planned to direct and implement educational changes in NYS.

Below are some of the presenters from our conferences this past year. We are always grateful to our presenters who dedicate their time and talents to our members!



Committee Programs for members

The Information Exchange Committee led by Co-Chairs **Camille Rutan (Pen)** and **Lisa Ireland (Broc)** met this year to learn about:

- The Board of Education's Role in the Budget Process;
- How to Keep Students and Staff Safe and Secure While Using Social Media Appropriately;
- Creating Inclusive Schools For Transgender/LGBTQ Students;
- APPR Changes;
- Cost Savings from Self Funding RASHP 2 and Educational Foundations;
- Current Trends in Substance Abuse;
- And Hear Local Regents Share Their Perspectives on the Direction of Education in NYS.

The Labor Relations Committee led by **Tom Abbott (Hil)** and **Andrea Costanza (Bri)**, shared negotiations updates at each meeting and discussed:

- Civil Service Hiring and Termination;
- Potential Impact of the \$15/hr Minimum Wage;
- Evidence Based Superintendent Evaluations;
- Innovative Settlements and Labor Practices;
- RASHP 2 Update;
- Pension Systems-How they Work and What Drives their Rates;
- Digital Based Employee Management System.

At the first meeting of the year, these committees identify future topics to pursue at their remaining meetings. A survey is also sent out during the summer to both committees in order to facilitate a more productive start for the fall.



Legislative Committee

The Legislative Committee prepares and promotes the Association's legislative positions. This year, under the leadership of **Ann Carmody (Web)** and **Lynn Fulmore (CC)**, the committee up-dated position papers on the role of SED and the Federal Government in public education and arranged and promoted meetings with NYS officials locally in the fall and in Albany in December.



In early February, the Legislative Committee hosted its annual local breakfast meeting with NYS lawmakers to discuss the value of public education in Monroe County and the NYS budget, especially the elimination of GEA and unfreezing the foundation aid formula.



Members also attended appointments with SED and NYS officials arranged by MCSBA in Albany late February in conjunction with the NYSSBA Capital Conference. Members met with legislators and representatives of SED and the Governor's office prior to the completion of the state budget to advance local districts needs and provide lawmakers with background information on the impact of proposed legislation.
