

From Our Executive Director





Yet another MCBSA year has come to a close and you

have accomplished much! Your leadership continues to inspire and should be a beacon to others on how those in governance should conduct themselves.

MCSBA continues to grow program offerings to the membership with more meetings and trainings. Attendance continues to be strong at all of our standing committees, in no small part to the topics chosen through the work of committee leadership. This year we changed up our Perspective Candidate Seminar to bring a broader overview of board service and offered both a Fall and Spring Law Conference.

These all took place in our new venue which has received rave reviews from the membership. The unexpected and last minute loss of our previous venue turned out to be a "window opening" opportunity and we are delighted to continue to develop our positive relationship with the Double Tree.

In June, we will be incorporating the recommendations from our Mentoring Committee for the state required New Governance seminar. The Mentoring Committee has also finalized their plans for the Board President/Superintendent symposium series that will begin this summer.

The Affiliate Network held their first event this past year and it was very well received. Two others are being scheduled to grow this opportunity for past MCSBA members to continue to be informed about the issues of public education. The steering committee members for the Affiliate Network also sent an email blast out to remind former members to vote on school budgets.

We continue to work on ways to increase, local, state and federal advocacy and how to improve the effectiveness of those events and appointments. The legislative committee has been the guiding force in keeping the association membership engaged and informed. This year we changed the departure time for our two day advocacy trip which better accommodated personal schedules, provided time to get into hotel rooms and still allow for full briefings before spending the next day advocating. We even garnered more press prior to our departure!

This November, we welcomed the Victor School District as an Associate member after a yearlong committee conversation about the MCSBA membership language in our Constitution. With the Steering and Executive committee approval, this recommendation will now go to the entire membership for their vote to make changes to our membership boundaries.

As you work together to overcome the challenges related to school district budgets with ever increasing mandates and new regulations, we hope that we have been a resource for you and a place to share information. Your dedication to your school district, to your community and to the greater good that public education provides for all students needs to be publicly commended and I want to thank you for all that you do!

It is a privilege to work for you, each and every day.

2017-2018 Highlights at MCSBA

Advocating, Educating, Representing

Funding for Public Education – Remains Association Goal #1

For the third year in a row, funding was the top priority for the association in what proved to be a very active year of advocacy on behalf of public education.

Members visited local legislators early in the fall to gauge the potential for a Constitutional Convention and to advocate against additional diversion of funds for charter schools.

In early December members traveled to Albany for targeted meetings with representatives from SED, Senate Finance, Assembly Ways and Means, and the Governor's Office. Advocacy efforts focused on unfreezing the foundation aid formula to provide districts with much needed revenue. Members also continued to push legislators to make them whole for Kindergarten students in full day programs added after the freeze. SED representatives provided members with insight into changes in the structure and funding for preschool education.

At the Legislative Breakfast in January, members shared their disappointment that the Governor vetoed legislation that would allow for BOCES construction costs and PILOTS to be introduced with in the tax cap. Local legislators were encouraged to repeal the supermajority requirement and rebate penalty for budgets exceeding the cap, citing the significant constraints NYS has over school revenues. Members reinforced the need for flexibility and local control for districts to efficiently sustain program and meet state mandates. Advocacy to remove the BOCES superintendent salary cap and limit diversion of funds from public schools continued as well.

In March, members again traveled to Albany for meetings with local legislative leaders to advocate for removal of the supermajority and to provide additional revenue for school districts. Members sought legislators insight on how Federal changes might impact education in NYS. Members cautioned that any added safety and security mandates for schools needed to be included outside the tax cap or program/staff reductions would be required to fund them. SED representatives provided background on the newly approved NYS ESSA Plan, sharing priorities for guidance and implementation with members.

Concerns about ESSA implementation costs and new reporting requirements were shared with legislators in local spring meetings. Proposals to decoupling standardized testing from teacher evaluations were also discussed.

MCSBA districts were well represented in all advocacy efforts.

The Communication Outreach Advisory Committee met to develop talking points on school district funding.

Members of the COAC Committee met in late October to develop talking points on the Tax Cap Levy. The document addressed what the cap is, how it is determined, what are the implications for school districts and what legislators can do to help schools cope with the cap.

Community Connections

MCSBA collaborates with a number of groups to promote public education.

MCSBA continues its representation on the **Council of Governments** (COG) where members collaborate with other officials on common issues. MCSBA's "Best for Less" publication was included in a report required by NYS on efficiencies and shared services filed by the Monroe County Executive.

ACT for Education continues to develop information about our public schools to help the greater Rochester community understand the value and strengths of public education in our county.

The committee worked with Causewave Community Partners again, and increased sponsorship for media advertisement highlighting the quality of Monroe County Schools as well as several earned media interest stories. The committee launched a new **Partners Program** in 2018 to expand the variety of ways sponsors can choose to support public schools.

A speaker's bureau was developed and presented to various business and leadership groups within the Rochester community on issues related to public education.

The **Monroe County Education Coalition** (MCEC) includes the PTA, school boards, superintendents, teacher unions, administrators, and school business officials. MCSBA provides and maintains a MCEC website at www.mcsba.org. This year MCEC welcomed new NYSUT regional director Carrie Andrews and wished a fond farewell to Tom Gillett

MCEC members identified the following five items for joint advocacy in 2017-2018:

- Full funding for public schools
- Tax cap relief (BOCES construction costs, pilots, healthcare costs)
- · Diversion of funds to charter schools, voucher programs, and tax credits
- Funding efficiencies
- Mental healthcare schools role vs. community's role.

Selected committee members met with the Democrat & Chronical editorial board in January to discuss the quality and strength of public schools in Monroe County as well as the challenges they face in the areas noted above.


By Getting our Messages Out Reporting

MCSBA also works with local media to help them understand and explain issues to the wider community.




Facts & Figures

• Special Education Up-Date: Trends, Economics, and Financial Aid.

















They also arranged and promoted meetings with NYS officials locally in the fall and spring, and hosted a Legislative Breakfast in January. The Committee sponsored two advocacy trips to Albany in December and March.

2017-2018 Mentoring Opportunities Strengthened

Simple changes were made to two annual training seminars this year. A veteran Board of Education member was added to the Prospective Candidates Seminar in addition to a Board of Education member typically in their first term. Exposure to members with different lengths of service was thought to give candidates a better view of the relationship building and growth that occurs over time with

board service. Similarly a panel of Board Presidents will present instead of just a single veteran board member at the yearly Governance Seminar in June. The panel was thought to give newly elected members a broader perspective of board service and mutual support across districts.

Lastly, a new Board Presidents/Superintendent Symposium series that had been under consideration for more than a year will begin in August. The aim of the series is to strengthen Board President/Superintendent leadership relationships.
