

SUMMER MEALS PROGRAM... AND IT'S FREE!



The East Rochester School Nutrition Program is participating in the U.S. Department of Agriculture's Summer Food Service Program, which provides free meals to students during the summer. All kids in the community, 18 years and younger, can participate; you need not be an ERSD resident.

When? Tuesday, July 5, 2022 through Friday, Aug. 12, 2022

What time? 7:30-10 am (breakfast) and 10:45 am-12:45 pm (lunch)

Where? High School Cafeteria (look for, and enter by, the yellow 'Kids Eat Free Here' flag)

How much? Free!

What's on the menu? Menus will be posted on the district's Website

- ➔ There are no income requirements and no registration is necessary, but meals must be eaten on site.
- ➔ Parents, guardians, and senior citizens can also purchase a meal for the nominal fee of \$2.65 for breakfast and \$4.55 for lunch.
- ➔ This program is fully funded by the USDA, so there is no cost to the district or taxpayers.
